The board of directors (the "Board") of the Company is pleased to announce that on 6 July 2017, Shaanxi TBEA New Energy Co., Ltd. ("Shaanxi New Energy"), a subsidiary of TBEA Xinjiang New Energy Co., Ltd., a holding company of the Company, has signed a cooperation agreement on the Houma Municipality 100MW Wind Power Plant Project (the "Cooperation Agreement") with the People's Government of Houma Municipality of Shanxi Province (the "Houma Municipal Government").
